#### Para-II

Maintainance of Service Books

On the verification of service books of the employees, it is noticed that they have reconstructed the service books of all the employees on the advise of the Department. Though all entries pertaining to annual increments and pay fixations have been recorded in the service books but service verifications on year to year basis is yet to be made. Besides, this appointment entries with letter no. and date of competent authority has not been made in the service books, The Principal may be asked to complete these entries on priority.

Para-III On examining the service book of Mr. Jose Kurian, Supdt. Gr.II, it is noticed that pay fixation on promotion to the post of Supdt.Gr.II, has not been gor approved from the Director of Education. The principal may be asked to get the needful done. Besides, earned leave availed by Mr. Jose Kurian has not been signed and verified by the Principal.

Para-IV One Sh. Ravi Dutt Minhas JLA has wrongly been sanctioned family planning incentive @ Rs. 150/- w.e.f. 1.1.96 instead of Rs.100/. Actually he was to be given this benefit in the time scale of 3120-5160/- instead of 4400-5000. So the recovery of overpayment @ Rs. 50 / permenth w.e.f. 1.1.96 to 31.3.2001 comes to Rs. 3159/-. The Principal to recover this amount from the official in lumpsum and deposit the same in the PLA account under intimation to this Directorate and infuture he may be given this incentive @ 100 PM from April enwards.

para-v From the perusal of the record it reveals that the appointment of Smt. Anjali Wadhawan JLA on the post of librarian (UGC scale) of 2289-4898 has wrongly been made by the Management for the period of 8 menths i.e. 1.3.99 to 31.18.99. Though the Deptt. has given its permission to fill up the post of librarian on 3 months basis in the first instance but the factual position was not brought to the notice of the Beptt. On going through the record of the interview held in the college inwhich Departmental nominee was also associated, it revealed that none of the candidate appeared in the interview were found eligible for the post of librarian being less requisite qualifications for the said post i.e. M.Lib.Science. The

interview board unaimously suggested the appointment of Nrs. Anjali Wadhawan JLA which is not in order. Infact the appointment from the pos of JLA(State Scale) to the post of libratian (UGC scale 2200-4000) is required to be approved from the Finance Deptt. H.P. Govt. In-view of the position explained above the party has worked out the overpayment of Rs.32730/- approximately as detailed be; ow:-

Further, that amount of Rs,32730/- has been proposed to be reduced from the due grant of the College till 28.2.2001.Smt. Anjali Wadhawan is eligible for the post of JLA only and this 95% Grant-in-aid has not been allowed to Smt. Anjali Wadhawan for the period from 3/99 to 18/99.

This position is submitted for the perusal of Director of Education.

Para-WI Sh. Khub ham Laberatery Attendant has been given family planning incentive @ Rs.180/-in the time scale of Rs.3128-6208 on 28.7.2k instand of Rs. 140/-. Infact he was drawing rate of increment @ Rs. 140/- on the time scale of Rs. 3126-4288 on 28.7.2000 as such he has been paid Rs. 40 per menth less since 28.7.2000. Principal to give this incentive to Sh. Khub Ram Lab. attendant from 28.7.2000-@ Rs. 140/-instead of Rs. 100 PM.

In another case one Sh. Phare lal Laboratory attendant has proceeded on E.O.L. without pay w.e.f. 29.4.2000 to join another assignment as stated by the college authority, thus he has been paid excess salary for 2 days i.e. 29.4.2000 to 30.4.2000 The Principal St. Bede's College Shimla, be asked to deposit excess amount paid to Sh. Piara Lal L.A. in PLA under intimation to this Directorate.

The cash beek and PLA account of this College has not been

maintained properly. Opening and closing balance of the cash book and PLA account does not tall with each other. The Principal has not deposited the 5% share of the Management and fee (income) with PLA stating that incase they deposits this amount in PLA account of the College, they face difficulty in withdrawing the same from PLA through treasury as such they deposits these funds in their bank account and utilisa for payment of salary when required. The Principal has also informed that treasury is not also authorising her to withdraw the payment from PLA more than 10 lacs once in a month as such their claim/demand remained pending with the treasury for months together. So to avoid delay in paying salary to the staff they deposits these funds in their bank account. This practice is not in-order. The 5% management share and income from fee fine etc. is required to be deposited in PLA account first and then withdraw to meet out the expenses on a/c of salary. The Principal may be advised to amend the procedure in future.

Actual Payees receipt (APRs)

The APRs have not regularly been signed by the various Officers/Officials of the College which is a serious lapse. The Principal to ensure that the APRs are signed by all concerned before the payment is released from PLA/ Bank.

It may hevever, be added that expenditure of the college for 2000-2001 has been taken upte 28.2.2091.

5% Share of the Management

Though the College has shown 1,43,987-00, 5% management share as excess deposits but this amount has not been deposited in the PLA/account of the college. This amount is deposited in their bank account which is not in order. The yearwise 5% management share which they deposited in bank account is enclosed at Ann-B for the kind perusal of wirthy Director of Education. As stated above the Principal should stop this practice infuture and deposit this amount in PLA. Similarly income from fee/fines admission fees etc. amy also be deposited in the PLA instead of their bank account.

#### Para-XI

Adminastrative charges for EPP/CPF

From the record produced by the Principal it reveals that they have not claimed in salary any administrative charges on a/c EPF/CPF service charges from the Department.

## Para-XII Revision of pay scales

Arrears bills on a/c revision of pay scales/award of sreselection scales w.e.f. 1.1.96 in r/s teaching and non-teaching staff w.e.f. 27.7.98 have been checked at randum and founf in-order as approved by the Directorate. But therough checking of these claims is required to be made for which copies of these claims have been obtained for verification from Section Officers (Audit) in the Directorate. Here, it is also noticed that in the cases where sreand selection scales have been awarded from 27.7.98 and the pay of an individual fixed at the minimum of the scale awarded to them—the next date of increment has been retained old whereas it is required to be given on completion of 12 months after the fixation of pay at minimum. This discrepancy is required to be seen at the Directorate level., with reference to the pay fixations cases of their counterparts in Govt. Colleges.

## Para-XIII House Rent Allowance and Medical Allowance

The Principal was asked through audit meme issued en 28.4.2001, about the plaiming of HRA and MA in spouse cases, but the Principal could not produce the mundertaking of the staff reason being that the college staff was on wacation after examination till 22.6.2001. She has assured that undertaking of each spouse case would be made available after they join. However, in the bills HRA and fixed MA is

is being claimed. This aspect could be examined after getting their undertaking from the concerned effice/Deptt. of the spouse. Detail of spouse case is also attached at Annexure-C.
